**Notes**

1. Your declaration covers donations you have made in the six years prior to signing this form and any that you may make in the future. You must therefore notify Life For The World if you change your name or address while the declaration is still in force. You may cancel the declaration at any time by notifying Life For The World - it will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
2. You must pay an amount of income tax and/or capital gains tax at least equal to the total tax reclaimable by charities (28p for each £1 given up to 5 April 2008 and 25p for each £1 you give from 6 April 2008) on all your Gift-aided donations in the tax year. From 6 April 2008 until 5 April 2011, the Government will pay charities an additional 3p on every pound you give – this additional relief for charities does not affect your personal tax position.
3. If, in the future, your circumstances change and in any year you no longer pay tax on your income and/or capital gains equal to the total tax reclaimable on all your Gift Aid donations, you should cancel your declaration (see note 1).
4. If you pay tax at the higher rate you can claim further tax relief for your Gift Aid donations on your Self-Assessment tax return.
